CONDITIONS OF ENTRY & GENERAL INFORMATION

1. All sheep must be registered with the Zwartbles Sheep Association.
2. All sheep will be sold in guineas and a commission of 5% will be charged and a further 1% levy will be charged and paid to the Zwartbles Sheep Association.
3. The sale will be held subject of the LAA Conditions of Sale in addition to the Auctioneers General Conditions of the Sale and the Rules and Regulations of the Zwartbles Sheep Association.
4. All sheep must have official ear tags.
5. Pedigree certificates and transfers will be dealt with by the auctioneers and the association following the sale.
6. All entry forms must be accompanied with the relevant entry fee of £7 + VAT (£8.22) per animal. (Payable to **RUTHIN FARMERS AUCTION CO. LTD.**)
7. All entry forms must be returned by the specified closing date of Saturday 27th August.
8. Pedigree certificates and NSP Genotype certificates/ Evidence of Genotype must accompany all entries.
9. MV Accredited sheep must be accompanied by the correct SAC Certificate of status form on the day of the sale.
10. All Vendors must comply with Defra regulations. (E.g. AML Movement form.)
11. Only Registered sheep may be entered in Official Zwartbles Sheep Association Sales
